## **Terms & Conditions**

These General Terms and Conditions (hereinafter: GTCs) are applied by Elizabeth Joyce Brownwood (mother's name: Klára Veress; ID number: 863116RA; tel: +36204846661), hereinafter referred to as the Organizer to determine the conditions for participating in the English camps organized by her (hereinafter: the Camp).

- 1. The present GTCs shall enter into force upon its publication and shall remain in force until it is replaced by an updated version or is revoked by the Organizer.
- 2. The scope of the GTCs extends to the minors participating in the camp (hereinafter: Child) and to their legal representative having sent an application on their behalf to participate in the camp to the Organizer (hereinafter: Parent).
- 3. Detailed information about the exact time, duration, program and services of the Camp and the participation fee is available and provided via e-mail at the e-mail address campbrownwoodhu@gmail.com.
- 4. The location of the Camp is 2483, Gárdony, Lévai utca 5. Holiday Üdülőház.
- 5. Applying to participate in the Camp is possible by filling out an application form available at https://www.campbrownwood.com
- 6. After receiving the application form, the Organizer sends a confirmation e-mail to the Parent containing the confirmation of the application to the Camp, the payment terms and all other information related to the Camp.
- 7. Prerequisites for participating in the Camp:
- 7.1 The age of the person participating in the Camp: 15.20.
- 7.2 The Parent pays the participation fee of the Camp to the Organizer within the given deadline.
- 7.3 Acceptance of the contents of the present GTCs.
- 8. The Parent acknowledges that the Camp also provides sleeping opportunities for Children choosing the option of Camp. In this case, the Parent takes over the Child at the end of the Camp, at a time agreed with the Organizer. For Children choosing only the Daycare Camp option, the Camp does not provide sleeping opportunities, such Children shall be taken home after the end of the daily program of the Camp at a time agreed with the Organizer.
- 9. During the Camp, the Parent entrusts the Child to the supervision of the Organizer and the teachers and volunteers employed by the Organizer. The Organizer declares that during the Camp she shall do her utmost to keep the camp to a high standard and to maintain high standard educational, developmental and leisure programs.

- 10. The Child may be taken out of the Camp only by the Parent, in any other cases the Parent must notify the Organizer thereof separately in writing.
- 11. Regarding the supervision of the Children, the Organizer undertakes to provide 1 accompanying person for every 10 children.
- 12. The Parent undertakes to prove that the Child is in a health condition suitable for participating in the camp by submitting a health statement signed by the Parent or an official medical certificate not older than 3 days as of the first day of the Camp. The Parent acknowledges that the organizer does not accept children who require individual care or continuous supervision. If the Parent does not provide the information specified in this section to the Organizer in advance and in a complete manner or does so only inaccurately, the Organizer shall not be liable in any way.
- 13. If a participating child falls ill during the Camp, the Organizer shall immediately notify the Parent via the contact details provided on the application form, who shall immediately remove the Child from the Camp for the purposes of medical examination. In case the Child already started the given turn of the Camp, the Organizer shall only provide the opportunity to replace the days missed due to illness subject to available places. If the Child is unable to start the camp due to illness and the Parent notifies the Organizer in writing no later than 12:00 on the Friday before the given week, the Organizer shall provide the opportunity to participate in a later turn for an additional fee (amounting to 18% of the weekly participation fee), subject to available places. In this case, the Parent is required to present a medical certificate as proof of the illness.
- 14. The Organizer shall assume responsibility for the supervision of the Child, which, however, does not extend to cases that are outside the scope of supervision (e.g. tearing of clothes, etc.) or cases when the Child refuses to comply with the instructions of his/her supervisors. The Parent acknowledges that the Organizer is not liable for any loss or damage to devices and values brought to the Camp by the Child (e.g. mobile phone, camera, music player, etc.)
- 15. Both the Child and the Parent are obliged to comply with the house rules applicable to the Camp, the internal rules of the Camp and the instructions of the camp leader, teacher and volunteer leading the group.
- 16. The Parent undertakes to transfer 50% of the participation fee as an advance to the bank account number of the Organizer indicated in the e-mail confirming the application within 10 days after filling out the application form.
- 17. The Parent undertakes to transfer the remaining 50% of the participation fee to the bank account number of the Organizer indicated in the e-mail confirming the

application until July 22nd for the first camp and July 29th for the second camp. In case the application form is submitted after July 22nd for the First camp, and July 29th for the Second camp, the Parent is obliged to pay the participation fee in full within 10 working days of the application, but not later than the first day of the chosen camp.

18. The Organizer provides the Parent with the opportunity to change his/her intention to participate or cancel the participation in the Camp. In the event of cancellation or amendment of the agreement, the contracting parties shall proceed as follows.

Cancellation policy: if the parent cancels the child's participation at least 20 working days prior to the starting date of the selected turn, the Organizer shall refund 50% of the participation fee to the Parent. If the Parent announces the intention to cancel following the above date, the Organizer shall be entitled to the full participation fee. Conditions for modification: depending on vacancies/available places, the modification of the date is free of charge. The parties agree that for the purposes of cancellation or modification, only a written notice (sent by postal letter or e-mail) shall suffice and that the above can only be affected if there is a vacancy in the camp. Otherwise, no modification is possible. If the Camp is frustrated for reasons attributable to the Organizer, the Parent shall be entitled to the full participation fee already paid.

- 19. In the course of her activities, the Organizer processes the data disclosed by the Parents to the extent necessary for the organization and operation of the Camp, in accordance with the Data Protection Act, exclusively for the conclusion of contracts, billing and other marketing purposes. The parent acknowledges that simultaneously with providing the data, he/she gives his/her consent to the data disclosed by him/her to be recorded and processed by the Organizer.
- 20. In matters not regulated in these GTCs, the agreement concluded between the parties and the relevant Hungarian legislation shall prevail. The Parties shall endeavour to settle their disputes arising from the contract amicably by mutual agreement. If the out of court settlement of the dispute is not successful, the Parties stipulate the exclusive jurisdiction of the District Court of Székesfehérvár. - 21. By submitting the application, the Parent expressly acknowledges that he/she has fully understood and accepted the conditions of participating in the Camp and the present GTCs, and furthermore declares that the data provided on the application form filled out by him/her are accurate
